

TOWNSHIP OF EVESHAM

ORDINANCE NO. 10-5-2004

AN ORDINANCE TO AMEND SECTION 3-65  
OF THE CODE OF THE  
TOWNSHIP OF EVESHAM  
ENTITLED, "RECREATION ADVISORY COMMITTEE"

BE IT ORDAINED AND ENACTED by the Township Council of the Township of Evesham, County of Burlington, State of New Jersey, as follows:

ARTICLE I. AMENDED SECTION.

Section 3-65 of the Code of the Township of Evesham, relating to the appointment of Members to the Recreation Advisory Committee is hereby amended to change the number of Members in Section 3-65(A) from ten (10) to eleven (11); to renumber existing subparagraphs (6) and (7) of Section 3-65(A) to (7) and (8) respectively, and to add the following new subparagraph (6):

"(6). There shall be one Member who shall be a student at Cherokee High School and shall serve for a term commensurate from the date of appointment, to High School graduation. The Appointee must, however, have completed her or his Sophomore year prior to appointment."

ARTICLE II. REPEALER, SEVERABILITY AND EFFECTIVE DATE.

- A. Repealer. Any and all Ordinances inconsistent with the terms of this Ordinance are hereby repealed to the extent of any such inconsistencies.
- B. Severability. In the event that any clause, section, paragraph or sentence of this Ordinance is deemed to be invalid or unenforceable for any reason, then the Township Council hereby declares its intent that the balance of the Ordinance not affected by said invalidity shall remain in full force and effect to the extent that it allows the Township to meet the goals of the Ordinance.
- C. Effective Date. This Ordinance shall take effect upon proper passage in accordance with the law.

**§ 3-65. Recreation Advisory Committee: appointment, term, powers and duties. [Amended 9-1-1981 by Ord. No. 30-9-81]**

A. There shall be a Recreation Advisory Committee composed of 10 members and two alternate members, who shall be residents of the Township of Evesham. All members shall serve without compensation and shall be appointed by the Evesham Township Council as follows: **[Amended 11-10-1998 by Ord. No. 42-11-98]**

- (1) Class I. There shall be one member who shall also be a member of the Evesham Township Board of Education and who shall be appointed for a term of three years or expiration of term, whichever occurs first.
- (2) Class II. There shall be one member who shall also be a member of the Marlton Recreation Council and who shall be appointed for a term of three years, or expiration of term, whichever occurs first.
- (3) Class III. There shall be one member who shall also be a member of the Senior Citizens Club and who shall be appointed for a term of three years or expiration of term, whichever occurs first.
- (4) Class IV. There shall be seven members who are residents of the Township of Evesham, three of whom shall be appointed for an initial term of two years and four of whom shall be appointed for an initial term of one year. At the expiration of each of the initial Class IV terms, each citizen member shall be appointed for a term of three years or expiration of term, whichever occurs first.
- (5) Class V. The Recreation Director shall serve as an ex officio member and shall attend and participate at all meetings, but that member shall not vote.
- (6) Alternate members. There shall be two alternate members who are residents of the Township of Evesham, both of whom shall be appointed for a term of two years. **[Added 2-16-1999 by Ord. No. 7-2-99** Editor's Note: This ordinance also redesignated former § 3-65A(6) as § 3-65A(7). ]
- (7) Any vacancy occurring other than the expiration of a term shall be filled for the unexpired term in the same manner as the original term.

B. The powers and duties of the Recreation Advisory Committee shall be as follows:

- (1) Advise the Township Council regarding ordinances which affect the recreation of the Township.
- (2) Advise the Township Council as to the recreational needs of the Township, including quarterly assessment reports to the Council on recreation achievements and problems and an assessment of the budget of the Department of Recreation.
- (3) Advise the Planning Board concerning recreation and open space, including review of subdivision and planned unit development recreation plans.
- (4) Advise the Director of Recreation concerning recreation programs and capital improvements.
