**AN ORDINANCE AMENDING CHAPTER XII, PARKS, PUBLIC AREAS, RECREATIONAL FACILITIES, SECTION 12-3, SUMMIT COMMUNITY POOL, OF "THE REVISED GENERAL ORDINANCES OF THE CITY OF SUMMIT 1996." (*Definitions, Membership and Use of Pool*)**

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF SUMMIT, as follows:

Section 1. That Section **12-3.2, Definitions**, of the above mentioned ordinance shall be amended and supplemented as follows:

**12-3.2 Definitions.** As used in this section:

*Family* shall include up to two adults living at the same address and their unmarried children who have not reached their 22<sup>nd</sup> birthday by June 1, and whose permanent address is the same. An adult son/daughter between the ages of 23 and 25 living at the same household as a family membership can purchase an associate membership in conjunction with a family membership.

**12-3.3 Membership.**

b. *Types of Memberships*

*Individual* – An individual membership is available to any resident or taxpayer, as defined in subsection 12-3.2 who is ~~eleven (11) year of age or older~~ at least 11 years of age by January 1 of the pool season or older.

*Associate* – An associate membership ~~i.e., nanny, caregiver, summer houseguests, grandchildren, niece, and nephew~~ is available to an individual who is at least 11 years of age ~~by pool opening~~ or older by January 1 of the pool season and who lives in the same household as a Family, Individual or Senior Citizen member ~~i.e., caregiver and summer houseguests~~. This membership must be purchased in conjunction with a Family, Individual or Senior Membership.

### 12-3.5 Use of Pool

- a. All guests must pay a one (1) day fee of five (\$5.00) dollars (three (\$3.00) dollars for children seventeen (17) and under) 2 years of age and under are free and
- b. All guests must be accompanied by a member, and sign in at the pool gate, against whose membership each guest's visit is charged, a member is allowed five (5) guests per day per season. ~~and no membership may thus accumulate more than fifteen (15) guest days per season (examples: one (1) guest for fifteen (15) days, or five (5) guests for three (3) days).~~ The member must remain with guests at all times.

Section 2. All Ordinances or parts or Ordinances inconsistent herewith are hereby repealed. This Ordinance shall be effective upon final passage and publication according to law.
