The League's Police and Fire Labor Data Service provides multiple resources tracking the trends in police and fire contract settlements.

Because we know how important and time sensitive this information is, we are releasing

this data in two editions. Available now is the first edition, with all data that has been collected since January 2019; the second edition is expected to be available as early as March 2020, and will contain data collected after release of the first edition. Once the additional data for the second edition is available, it will be emailed automatically to all those that purchased the first edition.


