 - ✓ Most others (Council cte, Redev Advisory)
- **Specialized, ad hoc**

ADMINISTRATION = TEAM



- Limit multiple leaders driving policy
 - Establish subcommittees
- Professional Staff is there long-term.
Rely on historical knowledge/Certifications & their dedication to job, municipality.


PLANNING IS POLICY
