On January 28, 2019 Governor Murphy signed into law a piece of legislation that increases the New Jersey Minimum wage and expanded the requirements to public employers. This legislation gradually increases the New Jersey Minimum wage, over five years, from \$8.85 a hour to \$15.00 a hour through gradual increases.
