New Jersey's Green Storm water Management Rules

The Webinar will discuss the New Jersey Department of Environmental Protection's (NJDEP) green infrastructure amendments to New Jersey's Storm water Management Rules which took effect on March 2, 2021. The amendments require the use of green infrastructure strategies to better manage polluted storm water runoff and reduce flooding compared with older storm water collection systems and approaches. The objective of the amendments was to help make New Jersey's watersheds cleaner by improving water quality, while increasing state communities' resilience to the increased storms and chronic flooding due to climate change.

The Webinar will provide a discussion of the legal aspects of the green infrastructure changes to the existing New Jersey Storm water Management Rules, as well as a practical discussion of how the changes can be implemented.
